## Meeting Minutes Agenda Items

- 1. Item 1: Minutes of September 30, 2025
  - a. A motion was made by Bridge and seconded by Ware to approve the minutes of September 30, 2025 as presented. Carried.
- 2. Item 2: Public Comments: no one signed up to speak.
- 3. Item 3: Airpark Update
  - a. Planned and prospective development of the north end of the Airpark was discussed.
  - b. Staff gave a detailed review of the Airpark Community Advisory Committee's (ACAC) annual report highlighting operational concerns and MCRA's commitments in response. The discussion also considered installing a staffed tower to address community issues and recommended that the ACAC committee conduct a further review.
- 4. Item 4: Resolution 50-1021-2025 was presented to the Board for consideration.
  - The purpose of the resolution is to name Keith Miller as the MCRA's Resident Agent.
  - b. A motion was made by Bridge and seconded by Biswas to appoint Keith Miller as MCRA's Resident Agent. Carried.
- 5. Closed Session: A motion was made by Bridge and seconded by Ware to enter into closed session to consult with counsel to obtain legal advice, pursuant to Maryland Code, General Provisions Article §3-305(b)(7); and to discuss the appointment, employment, assignment, promotion, discipline, demotion, compensation, removal, resignation, or performance evaluation of an appointee, employee, or official over whom it has jurisdiction, pursuant to Maryland Code, General Provisions Article §3-305(b)(1)(i). Topics included consultation with counsel to obtain legal advice and personnel matters concerning one or more specific appointees, employees, or officials.
